The Shuttle can be boarded at the far end of baggage claim, (double check this boarding information as it was correct last year). The drop off point would be Grand Marriott next door to the Embassy Suites. For those of you who will be making air reservations into Reno, the drive from the airport to South Lake Tahoe takes about 1.5 hours, depending on the driver and the weather.

IMPORTANT NOTE: For those of you departing from Reno Airport it would **NOT** be recommended to schedule a flight before 3PM on Friday.
